### **Item 9: Section 137 Grant**

9.1 To receive a report on the Section 137 grant issued to:

Killamarsh Heritage Society

A report was presented as follows:

Report to Killamarsh Parish Council from Killamarsh Heritage Society on a project to erect a plague to mark the location of where High Moor Colliery was situated.

In 2014 Killamarsh Heritage Society erected a memorial to Westthorpe Colliery in recognition of the villages mining history. Killamarsh Heritage Society paid for this and it was made by Daynes Monumentals.

Since that date attempts have been made to mark the location of High Moor Colliery. This has been a difficult and lengthy task and unachievable due to the site being at the junction of Hut Lane and Mansfield Road and the traffic constraints this presented. Any ideas we had for this project were unsuccessful.

So that we could still put a memorials to High Moor Colliery (also known as Blue Bell Pit) the current project is to put a plaque on the wall of the brick built planter on the grass verge near to the junction. Killamarsh Parish Council have agreed to a plague being put on the back of the 'Killamarsh' planter.

The plaque is on order from Freeman Daynes on a suitable design for the plaque.

The outer circular of the plaque is polished blue pearl granite with a white circular inlayed centre. sized 24" in diameter. The designs are coloured enamel with the inscription in silver and the dates in black.

A plaque in the same blue granite material with 'KILLAMARSH HERITAGE SOCIETY, ERECTED 2022' will sit below the circular plaque.

The plague will be erected as soon as production is complete.

Killamarsh Parish Council has awarded Killamarsh Heritage Society a grant of £200 as a contribution to this project (40%).

Killamarsh Heritage Society will cover the remaining 60%.

In addition to the plaque being erected on the wall, Killamarsh Heritage Society will plant up the top and around the base of the planter with seasonal plants and will maintain them. Killamarsh Heritage Society will purchase the plants and carry out the maintenance at their own expense.

If any more information is needed about the project Killamarsh Heritage Society will be pleased to provide it.
