
### **PUBLIC PARTICIPATION**

### **ENV239** Minutes from the previous meeting

RESOLVED: The minutes of the meeting held on 13th March 2024 are a true and accurate record.

b) To receive an update on any ongoing issues not covered as an agenda item.

The Deputy Clerk had provided a written report with updates of ongoing items.

### Belklane

There had since been a resident contact the Parish Office for an update on the flooding issues at the bottom of Belklane Park. The Deputy Clerk advised that she has contacted Derbyshire County Council and Councillor Renwick but has not received a response yet. This was chased up by the Deputy Clerk on 9th April.

### **Birchlands**

The office had contacted the approved supplier for the installation of the football posts and basketball net for a revised quote to include a tarmac surface at the basketball net. As no response was received from several attempts to contact the supplier, the Deputy Clerk advised that the office had contacted the other supplier for a revised quote, but they were unable to install a tarmac surface and advised a local contractor would be best.

RESOLVED: The office to obtain quotes for a contractor to install a tarmac surface for the basketball net.

### **CCTV**

The Deputy Clerk mentioned a reply had been received to the letter sent to the owner of the land at Rotherham Road regarding pruning the trees covering the lamppost intended for an ANPR camera. The Deputy Clerk also said that Derbyshire County Council had provided the lamppost number, with a recommendation to consider another post as the trees around the suggested post may need frequent maintenance.

RESOLVED: To change the ANPR camera location to lamppost 053610.

# Speed Indicator Devices

RESOLVED: The office to contact DCC and the SIDs supplier to enquire about new solar panels for the existing busy locations and moving the battery ones to the quieter locations where brackets are in place.

# ENV240 Litter & Dog Bins

- To consider and approve a replacement dog bin between 39 and 41 Peacock Close. The lid is missing and a resident has complained about the smell and that dog waste is being thrown onto their garden.

The cost of installing a replacement bin, with a chute is £364.76 + VAT.

RESOLVED: That the installation of a replacement bin is approved.

# ENV241 Village Green

- To consider and approve the installation of six planters on the Village Green from the quotations received.

Quote 1: £1080 + VAT - 6 x 1.2m square wooden sleeper planters Quote 2: £1436.64 - 6 x 1.2m square wooden sleeper planters

Quote 3: £1770 + VAT - 6 x 1m square heavy duty plastic planters

Quote 4: £3300 + VAT - 6 x 1m square wood effect planters

Cllrs agreed on the locations for the planters around the village green to make the area brighter and hopefully deter parking. All Cllrs agreed that Quote 1 is the most cost effective.

RESOLVED: That Quote 1 for 6 x 1.2m square wooden sleeper planters is approved for purchase and installation.

### ENV242 Benches

a) To consider and approve a replacement bench at the top of Long Lane at the junction with Mansfield Road due to damage and wear on the slats.

RESOLVED: That the replacement bench at the top of Long Lane at the junction with Mansfield Road is approved for purchase and installation.

b) To consider and approve a replacement bench at the bus stop on High Street near the war memorial. This bench has been removed as it had badly deteriorated.

Cllr Laws mentioned that the Community Trust put the original bench there with a plaque. The Deputy Clerk said that she would ask the Handyperson if he found a plaque when clearing the damaged bench from the location.

RESOLVED: That the replacement bench at the bus stop on High Street near the war memorial is approved for purchase and installation.

#### ENV243 Wildlife

- To consider whether to take any action with regards to the Hedgehog Highway project.

Cllr Tinley asked if the Hedgehogs R Us charity is a registered charity. Other councillors mentioned they have seen previous legitimate advertisement of the charity on the news and social media. Cllr Sherman said that this could be suited to school children in the area. All councillors agreed that it would be good to trial a donation of the Hedgehog Highway to Killamarsh Schools to encourage wildlife protection. Councillors also agreed it would be nice to see photos of the Hedgehog Highway being used.

RESOLVED: That the purchase of a Hedgehog Highway bundle is approved and to split and donate them to Killamarsh Junior School, Killamarsh Infant School and St Giles School.

### ENV244 Parks and Open Spaces

- To consider the next course of action with regards to Crofters Close Play Area (Birch Park) after NEDDC have agreed to discuss a proposal from the Parish Council to potentially lease the park.

RESOLVED: The office to arrange a meeting with NEDDC to discuss a potential lease of Crofters Close Play Area.

### ENV245 Trees and hedges

- To consider whether to engage a aboricultural consultant in Summer 2024 to undertake a tree survey of all trees on Parish Council land, providing a report, plan and recommendations. An approximate cost for this would be £1500.

The other option is to have a tree surgeon visit to recommend any essential work that is needed as happened in 2023. Summer is the preferable time to assess the trees as it is easier to identify any dead branches.

Cllr Tinley mentioned if Crofters Close could be looked at incase the lease goes ahead. Cllr Sherman raised the question of the ivy growing around the trees and if this a danger to them. Cllr Clough answered saying it can strangle the trees over time.

RESOLVED: The office to ask the NEDDC tree officer for recommendations and to obtain more quotes from aboricultural consultants to undertake a tree survey in Summer 2024.

# ENV246 Planning

- To consider a request from a resident for the Parish Council to investigate what options there are in relation to agreeing the street names for the developments at Primrose and Westthorpe.

Cllr Clough asked if the office can contact the MP's office to enquire about the street names being related to Killamarsh and if the Parish Council can have any involvement in the street names due the MP's office having more contact with the developers.

RESOLVED: The office to contact the MP's office with the enquiry about the street names being related to Killamarsh and if the Parish Council can have any involvement in the choice of names.

# Information about ongoing issues not included on the agenda

Purpose of Report: To update members with information about ongoing issues not included on the agenda

### **Allotments**

All payments have been received for this year. The tenant of a large allotment at Station Road has recently given notice and the plot was split into two and has now been let out. After the last allotment site visit by the committee, notice to improve letters were sent out and the plots will be re-inspected at the next site visit, planned for 11<sup>th</sup> June.

In one of the recently let plots the new tenant was taking down an old shed and suspected asbestos was found. The Office have called out a company to test and remove the substance.

# **Belklane**

The Handyperson has painted the goalposts.

### **Benches**

The replacement benches have been fitted at Long Lane and near the War Memorial.

# **Birchlands**

The office is still waiting for a quote to install a surface for the basketball net.

### Birch Park/Crofters Close

A meeting took place between the Parish Council and NEDDC to discuss how they could work together to make improvements to the Park.

### **CCTV**

We are awaiting a date for Derbyshire County Council to co-ordinate with the CCTV installers to fit plug sockets at the same time as the camera installation takes place.

### Dog Bins

The dog bins have been ordered for Beech Crescent and Peacock Close.

# Hedgehog Highway

The hedgehog highways have arrived and two schools so far have replied to say they would love to be involved. We are preparing some leaflets and instructions to go out with them. If any councillors would like to go into the schools to distribute them please let the office know.

# **High Moor**

CISWO would be willing in principle to consent to a playground development on the land that the Parish Council lease from them. They would require further details, such as plans of the proposed playground before formal written consent would be issued.

# **Solar Panels**

The solar panel installation on Killamarsh Community Hub is now complete.

# St Giles Churchyard, Killamarsh

In light of resident complaints about the state of the closed churchyard the Parish Council have arranged a meeting with North East Derbyshire District Council, who have responsibility for it, to discuss.

### **Tree Survey**

The office is in the process of obtaining three quotations for this, which will be brought to the next meeting for approval.

# Village Green

The six wooden planters have been ordered from Hobsons and we are waiting for an installation date.

# **Village Summer Planting**

The village planters and hanging baskets should be installed by 10<sup>th</sup> June.
