22/362 Chair's Announcements

The Chair welcomed everyone to the meeting and confirmed that all future meetings of full council would be held in the Parish Suite and committee meetings would remain in the Hub.

22/363 Apologies for Absence

Apologies were received from Cllr B Morris and the reason given was accepted.

22/364 Declaration of Disclosable Pecuniary & Other Interests

a. 22/365 Adjournment for Public Participation

A member of the public said that they hoped the parish council could find a space in the Hub for the Heritage Society. They also commented that even though they appreciated the achievements of Millie Bright, there were other people past and present who had done a lot for the village and should they not also be celebrated. Another member of the public said that it was important that communities celebrate their heritage and so was in support of the Heritage Society having a base in the Hub where they could display local history memorabilia.

22/366 Reports from County and District Councillors & Invited Guests

There were no county councillors in attendance.

The local PCSO was present and gave an update on crime statistics in Killamarsh. She said that the local SNT team are currently working on following up burglaries. She also said that anti-social behaviour seems to have improved since last year, for example, she had not observed young people sitting around in the precinct as much this year.

Cllr Laws asked what was being done to address the parking issues on Bridge Street and the PCSO explained that she was working in conjunction with the civil enforcement officers, who spend a designated number of hours in Killamarsh. Cllr Rice asked if the office could establish how many hours the enforcement officers were patrolling in Killamarsh each week.

Community Hub / CLOC Building

Cllr Laws said that it was important that the history and heritage of Killamarsh be preserved and he moved that the Heritage Society should be given a space in the Hub to display their archives. Cllr C Lacey agreed that they should be able to use the Hub as a base. The Chair agreed and said that if there were no objections then the Clerk should work with members of the Heritage Society to decide on a suitable space to utilise.

Cllr B Rice

Cllr Rice suggested that the parish council could work in conjunction with the Killamarsh Dynamos to decide on a suitable way to celebrate the achievements of Millie Bright. The Chair said that NEDDC had planned to potentially name the new fitness suite in Killamarsh Active after Millie Bright, but they had not received a response from her agent confirming if this would be something she would be interested in. Cllr Laws said that he is not disputing Millie Bright's achievements, however there were other people from Killamarsh who had done well or worked hard for Killamarsh who have not been previously recognised. Cllr Windle suggested that in the first instance we ask NEDDC to pursue the naming of Killamarsh Active after Millie, and everyone agreed.

RESOLVED: To work with NEDDC to look at naming the new fitness suite in Killamarsh Active after Millie Bright.

22/375

Community Bus

- To consider and approve being involved in the soft launch of the demand responsive transport service initiative by Derbyshire County Council.

The opportunity to get involved in a soft launch of this service arose as the parish council were seeking to provide a similar method of transport for older and disabled residents, picking them up from various points in the village and bringing them into the centre to use the shops or attend a coffee morning. There was concern from some Cllrs about the cost if residents don't have a gold card, and also about whether the wider DCC project would do exactly what the parish council was intending. However it was approved that the parish council would take part in the soft launch as it would be a good way of testing demand for a community bus service, at no cost to the parish council. The Deputy Clerk asked that Cllrs send her the names and contact details of any residents who would be able to use the transport service as part of the launch.

RESOLVED: That the Parish Council will be involved in the soft launch of the DfT project.

22/376 Donations

- To consider and approve the Parish Council making a donation to the Royal British Legion towards the purchase of a new Standard for the Killamarsh branch using the General Power of Competence.

The Clerk explained that as the Parish Council has 'General Power of Competence' then a donation such as this could be made. The Chair confirmed that the new standard would cost approximately £1000 and that the RBL were intending to do some fundraising. The Chair suggested that the parish council donate £500 and this was approved by everyone.

RESOLVED: That Killamarsh Parish Council donate £500 to the Royal British Legion towards the cost of a new Standard for the Killamarsh branch.

A member of the public voiced concern about flooding at their property due to the large amount of rainfall in October 2023, which had collected at the bottom of Belkline Park. They had been advised by Derbyshire County Council to use sandbags, but the resident did not think they provided enough protection from the large build up of water, and they had been having issues for a while whenever there was heavy rain. The member of the public was concerned for the damage this flooding could do to their property in future and they already had instances of damp and black mould on some of their property walls. This matter is on the agenda to discuss.

Birchlands play equipment

The Tots Bus is in the process of being ordered, and quotations for the football posts and a basketball net will be brought to the next meeting.

CCTV

Locations have been approved by DCC and the next stages are as follows:

- To arrange an unmetered supply certificate from the National Grid
- To register with an electricity supplier
- To register with the Information Commissioner's Office (ICO) and pay a data protection fee if required
- To ensure the CCTV policy is up-to-date and complies with current legislation
- To arrange testing of the lamp posts
- To apply to DCC for an installation licence

Cemetery gates automation

Neighbourhood Plan

The next meeting of the neighbourhood plan working group is Tuesday 30th January at 1pm.

Norwood

We are still awaiting the outcomes of the two licence applications to DCC to install a dropped kerb at the entrance to the playground and to install a new noticeboard near to the roundabout by the Sandwich Junction.

The new swing seat, to replace the one that was vandalised, is due to be delivered and installed at the beginning of February.

Cllr Tinley voiced concern for the amount of time it is taking for a response to be received regarding the licence applications.

RESOLVED: The Deputy Clerk to contact DCC to see if there are any updates.

Speed Indicator Devices

The SIDs were installed at the end of November 2023. They work via rechargeable batteries and due to the devices being situated in busy traffic locations the batteries are not lasting more than a week or two. As two people are needed to change the batteries this is being co-ordinated on a monthly basis, so there will be some periods of time when the SIDs will not be in action.

The Committee were concerned about the time the batteries lasted before they needed charging. They requested the office contact DCC to enquire about plugging the SIDs directly into the electricity supply.

RESOLVED: To contact DCC regarding electricity connections for the SIDs.

Tree maintenance

The office is waiting for a date from the agreed company for the essential tree work to be undertaken. The diseased tree at the Village Green is being left in situ at this time.

Village Green

There was a meeting of a village green working party on 12th December where the following ideas were discussed:

- Installation of low post and rail fencing around the grass area, leaving gaps for access and leaving the access roads clear.
- Installation of a kerb.
- Installation of picnic tables to encourage residents to use the Village Green as an open space.
- Planting flower beds and/or shrubs.
- Planting of new trees.
- Designating the narrow end of the Village Green as a parking space for the users of the Village Green, and fencing off the rest.
- Assessing the grass verge between the hedge line and the access road as a potential parking area.

An on-site working party meeting will be arranged in due course.

The Deputy Clerk has contacted Derbyshire County Council regarding the installation of a kerb along the main roadside of the Green. DCC had replied to say they did not have the funding to do this, but confirmed that the Parish Council could potentially commission this work themselves if they applied for a licence and used a contractor on the DCC approved list. The cost for this could be around £10,000.

Any legalities around sectioning off part of the Green for parking would need to be looked into by contacting NEDDC/DCC and the Open Spaces Society <https://www.oss.org.uk/>

RESOLVED: The Deputy Clerk to arrange an on site Village Green working party meeting and to invite Killamarsh Conservation Group.

ENV198 Policies

a) To consider and approve any amendments needed to the DRAFT KPC3 CCTV Policy

Cllr Tinley mentioned a useful guide found from GOV.uk that can be sent to all councillors for policy recommendations. Cllr Clough voiced the importance of adhering to Data Protection through a detailed policy.

RESOLVED: The office to send the draft CCTV policy to the ICO for recommendations.

b) To consider and approve any amendments needed to the DRAFT KPC69 Grit Bin Policy

RESOLVED: The Grit Bin Policy is recommended to Full Council for approval.

ENV199 Grit & Grit Bins

a) To consider a request for a new grit bin on Laburnum Grove

RESOLVED: It is recommended to Full Council that a grit bin should be installed near to the top of Laburnum Grove.

b) To consider a request for a new grit bin on Woodall Way

RESOLVED: It is recommended to Full Council that a grit bin should be installed on Woodall Way, High Moor.

ENV200 Memorials

a) To consider and approve the font, layout and cost for a plaque to remember the people affected by the 1998 incident at the SARP UK Plant (attached).

Cllr Tinley stated preference to the quality of quote 1, however Cllr Clough and Cllr Sherman thought this was a large price difference to quote 2. All Cllrs in agreement that quote 2 is preferred in the Traditional Brass option.

RESOLVED: The traditional brass option in quote 2 to be ordered and fixed in the Parish Suite entrance with the layout and font shown.

b) To consider a request from a resident to create a miners memorial for High Moor Colliery, which closed in 1992 (attached).

Cllr Laws suggested contacting Killamarsh Heritage Society for a possible collaboration on this. All councillors agreed this would be a good idea.

RESOLVED: The office is to contact Killamarsh Heritage Society to enquire about collaboration with the miners memorial request.

ENV201 Parks and Open Spaces

a) To consider any action required following a complaint by a resident about water running onto Church View from Belkane Park (photos attached).

Cllr Laws said that before the houses on Church View were built there was a large pond at the bottom of Belkane Park. Cllr Clough said that there was a drainage culvert at the bottom of the park installed by Derbyshire County Council, which the Parish Council have previously spent time keeping clear. The members of the public who raised this concern and were in attendance, confirmed the location of their property with the councillors. The councillors assured them this will be looked into further and in the first instance asked the office to contact DCC as expert advice would be needed.

RESOLVED: The office to contact DCC regarding the drainage at Belkline to arrange an assessment of the flooding issue.

b) To consider the installation of a footpath from the main entrance of Belkline Park to the playground, to enable easier access for pushchairs and wheelchairs.

The Deputy Clerk said this was initially raised by the Handymen while doing their weekly checks at the park. It was mentioned that during wet weather, the ground becomes slippery and unsafe with mud which could hinder access. All councillors were in agreement that a footpath is needed for practicality and safety. They also agreed it would be necessary to tidy the entrance area to the park from Belkline Drive.

RESOLVED: The office is to obtain quotes for the installation of a footpath from the main entrance of Belkline Park to the playground.

c) To consider a request from a resident to use the open space at High Moor for occasional archery practice.

The Deputy Clerk explained the residents request for granting access to practice occasional archery at the open space at High Moor. Cllr Clough, Cllr Laws and Cllr Tinley voiced concern for the safety of this. Cllr Tinley stated if an accident occurred while the resident was in practice, the Council may be liable for granting permission. Cllr Clough suggested that safety measures and agreements would have to be put in place, however that may not be viable due to the land being leased.

The councillors asked to pass on their thanks to the resident for asking for permission, however unfortunately permission cannot be granted in this case.

RESOLVED: Permission is not granted for the practice of archery on the open space at High Moor for health and safety reasons.

ENV202 Cemetery

- To consider and decide if any action is required with regards to information received from NEDDC about some recently installed headstones that exceed the permitted height.

This matter was discussed in closed session.

RESOLVED: The Committee agreed with NEDDC that grave memorials should not exceed the permitted height contained within the cemetery rules and will respond accordingly.

The Policy

1. Policy Statement

Killamarsh Parish Council believes that Health & Safety performance is an integral part of the efficient and cost-effective discharge of its duties and is aware of its responsibilities under the Health & Safety at Work Act 1974. The Parish Council therefore intends to meet those responsibilities as far as is reasonably practicable by incorporating good health and safety management within all its operations.

The objective of the Parish Council policy is to minimise risks to health, safety and welfare of its employees, voluntary workers, general public and others affected by its activities and to minimise risks to the environment. All reasonable measures will be taken to ensure that a safe working and community environment is created.

Members of the Parish Council have the responsibility for implementing this Policy and must ensure health and safety considerations are always given priority in planning and day-to-day supervision of work.

All employees and voluntary workers are expected to co-operate in carrying out this policy throughout the Parish Council's activities and must ensure that their own work, so far as is reasonably practicable, is carried out without risk to themselves or others.

All employees, voluntary workers and contractors associated with any works carried out by the Parish Council will be made aware of this policy and the importance of commitment to its objectives.

The organisation and arrangements for implementing the Policy are set out in the Policy document. The Policy will be kept up to date in response to changes in legislation or best practice. To ensure this, the Policy, and the way in which it has operated, will be reviewed annually or as the need arises.

2. Organisation (Roles and Responsibilities)

2.1 Duties and Responsibilities of Parish Councillors

All Parish Councillors are jointly responsible for the implementation of this Health & Safety Policy, for monitoring the day-to-day administration of the Council's affairs, and ensuring that all insurance policies are in date.

In doing so, they will ensure that:

A copy of this policy is circulated to all employees and voluntary workers on appointment. Opportunity will be given to discuss this policy on an individual basis to ensure that it is fully understood and implemented.

The Council's activities are monitored to ensure that the objectives of the Health & Safety Policy are being complied with.

Contracts of employment include compliance with statutory and company health, safety & environmental requirements.

All staff have adequate competence and training for carrying out their specific jobs and for ensuring the health, safety and welfare of themselves and those around them.

Employees and voluntary workers are aware of the hazards which may exist within the operation of their tasks, and that they fully understand and observe all aspects of the Parish Council's Health & Safety Policy.

No employee or voluntary worker shall be engaged in any work activity where technical knowledge or experience is necessary to prevent danger or injury unless he or she possesses such knowledge or experience, or is under supervision of a competent person having regard to the nature of the work.

Safe methods of work are adopted.

- all suppliers comply with Section 6 of the Health & Safety at Work Act (HASAWA) in supplying articles and substances that are safe and without risk to health when properly used and to provide information to enable them to be properly used;
- any accidents arising out of the Council's activities are recorded, reported and investigated as detailed in the accident reporting procedure.
- regular inspections of equipment are carried out and necessary records kept.

2.2 Duties and Responsibilities of all Employees and Voluntary Workers

- Employees and voluntary workers have a responsibility to conform to the Parish Council policy and with the Health & Safety at Work etc. Act 1974 and associated legislation.
- Employees and voluntary workers have a statutory duty to take reasonable care of the safety and health of themselves and others who may be affected by their acts or omissions and to cooperate with the company to enable it to fulfil statutory obligations. They should also ensure that they are physically fit and technically responsible for the work requested of them.

- Employees and voluntary workers have responsibility for properly using any safety devices involved in their work. They will not recklessly interfere with or misuse anything provided in the interests of health, safety, and welfare.
- All accidents and near miss incidents shall be reported to the Parish Clerk and recorded in the Parish Council accident book as soon after the event as possible. Employees and voluntary workers will also co-operate with the management in investigating all accidents and near misses.
- Employees and voluntary workers must request assistance or advice about any area of work that they are not familiar with.

2.3 Duties and Responsibilities of all Contractors

Contractors must comply with the following:

- Any contractors employed by Killamarsh Parish Council shall be responsible for always conducting themselves safely and in complying with the Parish Council's Health & Safety Policy.
- Any work carried out must be fully in compliance with statutory legislation and Codes of Practice to ensure the health and safety of their own employees and others on and off site.
- All tools and equipment that they bring onto site must be safe and in sound working order. All necessary guards and safety devices must be in place and necessary certificates must be available for checking.
- Any injury sustained whilst on site must be reported to the Parish Clerk immediately.
- All electrical equipment must have a valid Portable Appliance Test certificate.
- Contractors must provide written risk assessments and method statements where necessary, before commencing work for or on behalf of the Parish Council.

2.4 Duties and Responsibilities of all Visitors

Killamarsh Parish Council owes a duty of care to visitors to the Parish Council controlled areas of the village. Parish Councillors will ensure so far as is reasonably practicable that safe access and egress is available and that that areas are maintained in a safe condition. Visitors are expected to take note of any health and safety notices to ensure their safety whilst in Council controlled areas.

3. Arrangements

3.1 The enforcement agency for Local Authorities is the Health & Safety Executive. Any site visit carried out by Statutory Inspectors shall be co-ordinated with the full cooperation of Parish Councillors and any recommendations carried out as soon as reasonably practicable.

3.2 Risk Assessments:

Generic risk assessments will be co-ordinated by the Parish Clerk for all public areas and assets controlled by the Parish Council. These assessments will be recorded, monitored, and reviewed annually.

3.3 Training Parish Councillors are responsible for ensuring that appropriate health & safety training is provided for employees and voluntary workers. The Parish Clerk is responsible for maintaining records of such training.

3.4 Accident reporting:

The Parish Clerk must be notified immediately if an accident occurs to anyone whilst on Parish Council business. This includes Parish Councillors, employees, voluntary workers, visitors, contractors etc. A form in the accident book must be completed and returned to the Clerk. The Parish Clerk will ensure that the requirements of RIDDOR (The Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995) are complied with. Where required, accidents and near misses shall be investigated by the Parish Clerk and remedial actions recommended to the Parish Council where necessary. Where the activity which gave rise to the accident is under the control of a nominated Parish Councillor then that person shall assume the responsibilities of the Parish Clerk in the preceding paragraph.

3.5 Provision and Use of Work Equipment:

If equipment provided by the employer is damaged or faulty the employee is responsible for the immediate return or report of such equipment to the employer for repair or replacement. (Provision and use of Work Equipment Regulations 1998) If the equipment is lost or damaged through negligence, there is an onus on the employee to report such loss or damage immediately.

3.6 Procurement of Materials, Equipment & Contractors:

Anyone who purchases or hires materials, equipment or contractors on behalf of the Parish Council must ensure that they have read and fully understand this health and safety policy. All suppliers are asked to provide full information on any hazards associated with the equipment or materials supplied and any precautions required. This information must then be passed on to the Parish Clerk in order to be recorded.

3.7 Violence/Personal Safety:

To avoid violence and aggression from members of the public or contractors, all staff should avoid getting into a confrontational situation. Always remain polite, but back off from situations that are potentially dangerous. Any incidents should be reported to the Clerk who may call the police, if it is considered necessary.

3.8 Inspections & Documentation Review:

An annual inspection of village assets will be carried out and the findings recorded. Any serious defects/items for attention must be actioned immediately. Activity risk assessments, the health and safety policy document and all other health and safety documentation will also be reviewed annually considering any changes in personnel, procedural or physical changes.

The Policy

- The following procedure will be adopted for dealing with complaints about the Council's administration or its procedures. Complaints about a policy decision made by the Council will be referred back to the Council, or relevant Committee, as appropriate, for consideration.
- This procedure does not cover complaints about the conduct of a Member of the Parish Council. These will be dealt with under the code of conduct via the Monitoring Officer.
- If a complaint about procedures, administration, or the actions of any of the Council's employees is notified orally to a Councillor, or to the Clerk to the Council, a written record of the complaint will be made, noting the name and contact details of the complainant and the nature of the complaint.
- The complainant will be asked to put the complaint in writing to the Clerk at Killamarsh Community Hub, Killamarsh Community Campus, Killamarsh, Derbyshire, S21 1DY. The complaint will be dealt with within 14 days of receipt. Refusal to put the complaint in writing does not necessarily mean that the complaint cannot be investigated, but it is easier to deal with if it is in writing.
- On receipt of a written complaint, the Clerk (except where the complaint is about his or her own actions) or Chairman of Council (if the complaint relates to the Clerk), will seek to settle the complaint directly with the complainant. This will not be done without first notifying any person complained about and giving him or her an opportunity to comment. Efforts should be made to resolve the complaint at this stage.
- Where the Clerk or a Councillor receives a written complaint about the Clerk's actions, he or she shall refer the complaint to the Chairman of Council. The Clerk will be formally advised of the matter and given an opportunity to comment.
- The Clerk will report any complaint disposed of by direct action with the complainant to the next meeting of the Council.
- The Clerk to the Council will report any complaint that has not been resolved to the next meeting of the Council. The Clerk will notify the complainant of the date on which the complaint will be considered, and the complainant will be offered an opportunity to explain the complaint to the Council orally.
- Matters relating to Grievance or Disciplinary proceedings that are taking, or are likely to take place, should be dealt with in accordance with the Council's Grievance and Disciplinary procedures.
- The Council may consider whether the circumstances of any complaint warrant the matter being discussed in the absence of the press and public, but any decision on the complaint will be announced at the Council meeting in public.
- The Council may consider in the circumstances of any complaint whether to make any without liability payment or provide other reasonable benefit to any person who has suffered loss because of the Council's maladministration. Any payment may only be authorised by the Council after obtaining legal advice and advice from the Council's auditor on the propriety of such a payment.
- As soon as possible after the decision has been made (and in any event not later than 10 days after the meeting) the complainant will be notified in writing of the decision and any action to be taken.
- The Council may defer dealing with any complaint if it is of the opinion that issues arise on which further advice is necessary. The advice will be considered, and the complaint dealt with at the next meeting after the advice has been received.

The Policy

Your personal data – what is it?

“Personal data” is any information about a living individual which allows them to be identified from that data (for example a name, photographs, videos, email address, or address). Identification can be directly using the data itself or by combining it with other information which helps to identify a living individual (e.g. a list of staff may contain personnel ID numbers rather than names but if you use a separate list of the ID numbers which give the corresponding names to identify the staff in the first list then the first list will also be treated as personal data). The processing of personal data is governed by legislation relating to personal data which applies in the United Kingdom including the General Data Protection Regulation (the “GDPR”) and other legislation relating to personal data and rights such as the Human Rights Act.

Who are we?

This Privacy Notice is provided to you by the Killamarsh Parish Council which is the data controller for your data.

Other data controllers the council works with:

- Information Commissioners Office
- HMRC
- North East Derbyshire District Council
- Derbyshire County Council
- Derbyshire Local Councils Association
- Unity Trust Bank

We may need to share your personal data we hold with them so that they can carry out their responsibilities to the council. If we and the other data controllers listed above are processing your data jointly for the same purposes, then the council and the other data controllers may be “joint data controllers” which mean we are all collectively responsible to

you for your data. Where each of the parties listed above are processing your data for their own independent purposes then each of us will be independently responsible to you and if you have any questions, wish to exercise any of your rights (see below) or wish to raise a complaint, you should do so directly to the relevant data controller.

A description of what personal data the council processes and for what purposes is set out in this Privacy Notice.

The council will process some or all of the following personal data where necessary to perform its tasks:

- Names, titles, and aliases, photographs.
- Contact details such as telephone numbers, addresses, and email addresses.
- Where they are relevant to the services provided by a council, or where you provide them to us, we may process information such as gender, age, marital status, nationality, education/work history, academic/professional qualifications, hobbies, family composition, and dependants.
- Where you pay for activities such as use of a council hall, financial identifiers such as bank account numbers, payment card numbers, payment/transaction identifiers, policy numbers, and claim numbers.
- The personal data we process may include sensitive or other special categories of personal data such as criminal convictions, racial or ethnic origin, mental and physical health, details of injuries, medication/treatment received, political beliefs, trade union affiliation, genetic data, biometric data, data concerning and sexual life or orientation.

How we use sensitive personal data

- We may process sensitive personal data including, as appropriate:
 - information about your physical or mental health or condition in order to monitor sick leave and take decisions on your fitness for work.
 - your racial or ethnic origin or religious or similar information in order to monitor compliance with equal opportunities legislation.
 - in order to comply with legal requirements and obligations to third parties.
- These types of data are described in the GDPR as “Special categories of data” and require higher levels of protection. We need to have further justification for collecting, storing, and using this type of personal data.
- We may process special categories of personal data in the following circumstances:
 - In limited circumstances, with your explicit written consent.
 - Where we need to carry out our legal obligations.
 - Where it is needed in the public interest.
- Less commonly, we may process this type of personal data where it is needed in relation to legal claims or where it is needed to protect your interests (or someone

else's interests) and you are not capable of giving your consent, or where you have already made the information public.

Do we need your consent to process your sensitive personal data?

- In limited circumstances, we may approach you for your written consent to allow us to process certain sensitive personal data. If we do so, we will provide you with full details of the personal data that we would like and the reason we need it, so that you can carefully consider whether you wish to consent.

The council will comply with data protection law. This says that the personal data we hold about you must be:

- Used lawfully, fairly and in a transparent way.
- Collected only for valid purposes that we have clearly explained to you and not used in any way that is incompatible with those purposes.
- Relevant to the purposes we have told you about and limited only to those purposes.
- Accurate and kept up to date.
- Kept only as long as necessary for the purposes we have told you about.
- Kept and destroyed securely including ensuring that appropriate technical and security measures are in place to protect your personal data to protect personal data from loss, misuse, unauthorised access, and disclosure.

We use your personal data for some or all of the following purposes:

- To deliver public services including to understand your needs to provide the services that you request and to understand what we can do for you and inform you of other relevant services.
- To confirm your identity to provide some services.
- To contact you by post, email, telephone or using social media (e.g., Facebook, Twitter, WhatsApp).
- To help us to build up a picture of how we are performing.
- To prevent and detect fraud and corruption in the use of public funds and where necessary for the law enforcement functions.
- To enable us to meet all legal and statutory obligations and powers including any delegated functions.
- To carry out comprehensive safeguarding procedures (including due diligence and complaints handling) in accordance with best safeguarding practice from time to time with the aim of ensuring that all children and adults-at-risk are provided with safe environments and generally as necessary to protect individuals from harm or injury.
- To promote the interests of the council.
- To maintain our own accounts and records.
- To seek your views, opinions, or comments.
- To notify you of changes to our facilities, services, events and staff, councillors, and other role holders.

- To send you communications which you have requested and that may be of interest to you. These may include information about campaigns, appeals, other new projects, or initiatives.
- To process relevant financial transactions including grants and payments for goods and services supplied to the council.
- To allow the statistical analysis of data so we can plan the provision of services.

Our processing may also include the use of CCTV systems for the prevention and prosecution of crime.

What is the legal basis for processing your personal data?

The council is a public authority and has certain powers and obligations. Most of your personal data is processed for compliance with a legal obligation which includes the discharge of the council's statutory functions and powers. Sometimes when exercising these powers or duties it is necessary to process personal data of residents or people using the council's services. We will always take into account your interests and rights. This Privacy Notice sets out your rights and the council's obligations to you.

We may process personal data if it is necessary for the performance of a contract with you, or to take steps to enter into a contract. An example of this would be processing your data in connection with the use of sports facilities, or the acceptance of an allotment garden tenancy.

Sometimes the use of your personal data requires your consent. We will first obtain your consent to that use.

Sharing your personal data

This section provides information about the third parties with whom the council may share your personal data. These third parties have an obligation to put in place appropriate security measures and will be responsible to you directly for the manner in which they process and protect your personal data. It is likely that we will need to share your data with some or all of the following (but only where necessary):

- The data controllers listed above under the heading "Other data controllers the council works with".
- Our agents, suppliers, and contractors. For example, we may ask a commercial provider to publish or distribute newsletters on our behalf, or to maintain our database software.
- On occasion, other local authorities or not for profit bodies with which we are carrying out joint ventures e.g., in relation to facilities or events for the community.

How long do we keep your personal data?

We will keep some records permanently if we are legally required to do so. We may keep some other records for an extended period of time. For example, it is currently best practice

to keep financial records for a minimum period of 8 years to support HMRC audits or provide tax information. We may have legal obligations to retain some data in connection with our statutory obligations as a public authority. The council is permitted to retain data in order to defend or pursue claims. In some cases, the law imposes a time limit for such claims (for example 3 years for personal injury claims or 6 years for contract claims). We will retain some personal data for this purpose as long as we believe it is necessary to be able to defend or pursue a claim. In general, we will endeavour to keep data only for as long as we need it. This means that we will delete it when it is no longer needed.

Your rights and your personal data

You have the following rights with respect to your personal data:

When exercising any of the rights listed below, in order to process your request, we may need to verify your identity for your security. In such cases we will need you to respond with proof of your identity before you can exercise these rights.

1) The right to access personal data we hold on you

- At any point you can contact us to request the personal data we hold on you as well as why we have that personal data, who has access to the personal data and where we obtained the personal data from. Once we have received your request, we will respond within one month.
- There are no fees or charges for the first request but additional requests for the same personal data or requests which are manifestly unfounded or excessive may be subject to an administrative fee.

2) The right to correct and update the personal data we hold on you

- If the data we hold on you is out of date, incomplete or incorrect, you can inform us, and your data will be updated.

3) The right to have your personal data erased

- If you feel that we should no longer be using your personal data or that we are unlawfully using your personal data, you can request that we erase the personal data we hold.
- When we receive your request, we will confirm whether the personal data has been deleted or the reason why it cannot be deleted (for example because we need it for to comply with a legal obligation).

4) The right to object to processing of your personal data or to restrict it to certain purposes only

- You have the right to request that we stop processing your personal data or ask us to restrict processing. Upon receiving the request, we will contact you and let you know if we are able to comply or if we have a legal obligation to continue to process your data.

5) The right to data portability

- You have the right to request that we transfer some of your data to another controller. We will comply with your request, where it is feasible to do so, within one month of receiving your request.

6) The right to withdraw your consent to the processing at any time for any processing of data to which consent was obtained

- You can withdraw your consent easily by telephone, email, or by post (see Contact Details below).

7) The right to lodge a complaint with the Information Commissioner's Office.

Transfer of Data Abroad

Any personal data transferred to countries or territories outside the European Economic Area ("EEA") will only be placed on systems complying with measures giving equivalent protection of personal rights either through international agreements or contracts approved by the European Union. Our website is also accessible from overseas so on occasion some personal data (for example in a newsletter) may be accessed from overseas.

Further processing

If we wish to use your personal data for a new purpose, not covered by this Privacy Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.

We keep this Privacy Notice under regular review, and we will place any updates on this notice,

The Policy

1. Purpose

This document defines an Information Security Incident and the procedure to report an incident.

2. Scope

This document applies to all councillors, committees, working parties, employees of the Council, contractual third parties and agents of the Council who have access to information systems or information used for Killamarsh Parish Council purposes.

3. Definition

An information security incident occurs when data or information is transferred or is at risk of being transferred to somebody who is not entitled to receive it, or data is at risk from corruption.

4. An Information Security Incident includes:

- The loss or theft of data or information.
- The transfer of data or information to those who are not entitled to receive that information.
- Attempts (either failed or successful) to gain unauthorised access to data or information storage or a computer system.
- Changes to information or data or system hardware, firmware, or software characteristics without the Council's knowledge, instruction, or consent.
- Unwanted disruption or denial of service to a system.
- The unauthorised use of a system for the processing or storage of data by any person.

5. When to report

All events that result in the actual or potential loss of data, breaches of confidentiality, unauthorised access or changes to systems should be reported as soon as they happen.

6. Action on becoming aware of the incident

Follow the information security procedure, according to the type of incident.

7. How to report

Report to the Data Protection Officer, Local Council Public Advisory Service. ceo@lcpas.co.uk or 01284 766885.

The Data Protection Officer will require you to supply further information, the nature of which will depend upon the nature of the incident. However, the following information must be supplied:

- Contact name and number of the person reporting the incident.
- The type of data or information involved.
- Whether the loss of the data puts any person or other data at risk.
- Location of the incident.
- Inventory numbers of any equipment affected.
- Date and time the security incident occurred.
- Location of data or equipment affected.
- Type and circumstances of the incident.

8. What to Report

All Information Security Incidents must be reported.

9. Examples of Information Security / Misuse Incident Protocols

Information Security Incidents are not limited to this list, which contains examples of some of the most common incidents.

Malicious Incident:

- Computer infected by a virus or other malware (e.g., spyware or adware).
- An unauthorised person changing data.
- Receiving and forwarding chain letters - including virus warnings, scam warnings and other emails which encourage the recipient to forward onto others.
- Social engineering - Unknown people asking for information which could gain them access to Council data (e.g., a password or details of a third party).
- Unauthorised disclosure of information electronically, in paper form or verbally.
- Falsification of records, inappropriate destruction of records.
- Denial of Service, for example.

- Damage or interruption to Killamarsh Parish Council equipment or services caused deliberately e.g., computer vandalism.
- Connecting non-council equipment to the Council network.
- Unauthorised Information access or use.
- Giving information to someone who should not have access to it - verbally, in writing or electronically.
- Printing or copying confidential information and not storing it correctly or confidentially.

Access Violation:

- Disclosure of logins to unauthorised people.
- Disclosure of passwords to unauthorised people e.g., writing down your password and leaving it on display.
- Accessing systems using someone else's authorisation e.g., someone else's user id and password.
- Inappropriately sharing security devices such as access tokens.
- Other compromise of user identity e.g., access to network or specific system by unauthorised person.
- Allowing unauthorised physical access to secure premises e.g., server room, scanning facility, dept area.

Environmental:

- Loss of integrity of the data within systems and transferred between systems.
- Damage caused by natural disasters e.g., fire, burst pipes, lighting etc.
- Deterioration of paper records.
- Deterioration of backup tapes.
- Introduction of unauthorised or untested software.
- Information leakage due to software errors.

Inappropriate use:

- Accessing inappropriate material on the internet.
- Sending inappropriate emails.
- Personal use of services and equipment in work time.
- Using unlicensed Software.
- Misuse of facilities, e.g., phoning premium line numbers.

Theft / loss Incident:

- Theft / loss of data - written or electronically held.
- Theft / loss of any Killamarsh Parish Council equipment including computers, monitors, mobile phones, memory sticks, CDs.

Accidental Incident:

- Sending an email containing sensitive information to 'all staff' by mistake.

- Receiving unsolicited mail of an offensive nature, e.g., containing pornographic, obscene, racist, sexist, grossly offensive or violent material.
- Receiving unsolicited mail which requires you to enter personal data.

Miss keying:

- Receiving unauthorised information.
- Sending information to wrong recipient.

10. Escalation

Serious incidents will be escalated via the national WARP scheme if determined to be of national value.

The Policy

1. Purpose

The purpose of this policy is to provide a framework for reporting and managing data security breaches affecting personal or sensitive personal data (defined below) held by Killamarsh Parish Council.

2. What is a personal data security breach?

A personal data security breach is any event that has the potential to affect the confidentiality, integrity or availability of personal data held by Killamarsh Parish Council in any format. Examples of personal data security breaches:

- the disclosure of confidential data to unauthorised individuals.
- loss or theft of portable devices or equipment containing identifiable personal, confidential, or sensitive data e.g., PCs, USB, mobile phones; Laptops, disks etc.
- loss or theft of paper records.
- inappropriate access controls allowing unauthorised use of information.
- attempts to gain unauthorised access to computer systems, e.g., hacking.
- viruses or other security attacks on IT equipment systems or networks.
- breaches of physical security e.g., forcing of doors or windows into secure room or filing cabinet containing confidential information.
- confidential information left unlocked in accessible areas.
- insecure disposal of confidential paper.
- leaving IT equipment unattended when logged-in to a user account without locking the screen to stop others accessing information.
- publication of confidential data on the internet in error and accidental disclosure of passwords.
- misdirected emails or faxes containing identifiable personal, confidential, or sensitive data.

3. What types of data do these procedures apply to?

These procedures apply to:

- all personal data created or received by Killamarsh Parish Council in any format (including paper records), whether used in the workplace, stored on portable devices and media, transported from the workplace physically or electronically or accessed remotely.
- personal data held on all Killamarsh Parish Council IT systems.
- any other IT systems on which Killamarsh Parish Council data is held or processed.

4. Who is responsible for managing personal data security breaches?

Personal data security breaches are managed by the Data Controller, which is the Parish Council.

5. Procedure for reporting data security breaches.

In the event of a breach of data security occurring, it is vital to ensure that it is dealt with immediately and appropriately to minimise the impact of the breach and prevent a recurrence.

If a breach or potential or suspected data breach has been reported to you, please report this immediately to the Chair of the Parish Council and Clerk.

The data breach document should be completed. This will enable all the relevant details of the incident to be recorded consistently and communicated on a need-to-know basis to relevant personnel so that prompt and appropriate action can be taken to resolve the incident.

Step 1: Identification and initial assessment of the incident

If you are aware that a data security breach has occurred, please report it immediately to the Chair of the Parish Council and Clerk. They should conduct an initial assessment of the incident by establishing:

- if a personal data security breach has taken place; if so:
- what personal data is involved in the breach.
- the cause of the breach.
- the extent of the breach (how many individuals are affected).
- the harms to affected individuals that could potentially be caused by the breach; and
- how the breach can be contained.

Following this initial assessment an appropriate lead investigator will be appointed to investigate the incident.

The Lead Investigator will determine the **severity** of the incident using the reference to the table below and by completing part 2 of the Data Security Breach Report Form. The severity of the incident will be categorised on a scale of 1 to 6. Where incidents are rated 3 or above this will be reported directly to the full Parish Council.

Rating	Reputation	Individuals potentially affected
0	No significant reflection on any individual or body. Media interest very unlikely.	Minor breach of confidentiality. Only a single individual affected.
1	Damage to an individual's reputation. Possible media interest (e.g., prominent member of the Parish Council involved).	Potentially serious breach. Less than 5 people affected, or risk assessed as low (e.g., files were encrypted).
2	Damage to a department's reputation. Some local or subject specific media interest that may not go public.	Serious potential breach & risk assessed high (e.g., unencrypted sensitive/health records lost) Up to 20 people affected.
3	Damage to a service's reputation / Parish Council member involved. Low key local or media coverage.	Serious breach of confidentiality e.g., up to 100 people affected and/or identifiable or particularly sensitive i.e., redundancies restructuring.
4	Damage to Parish Council's reputation / local media coverage.	Serious breach with either particular sensitivity (e.g., sexual or mental health details, identifying information of vulnerable people), or up to 1000 people affected.
5	Damage to Parish Councils reputation / national media coverage.	Serious breach with potential for ID theft or over 1000 people affected.
6	Monetary Penalty imposed by ICO	Restitution to injured parties. Other Liabilities Additional security legal costs.

Step 2: Containment and Recovery

Once it has been established that a data breach has occurred, the Parish Council needs to take immediate and appropriate action to limit the breach.

The Lead Investigator and relevant staff will:

- Establish who needs to be made aware of the breach.
- Establish whether there is anything that can be done to recover any losses and limit the damage the breach can cause.
- Establish if it is appropriate to notify affected individuals immediately.
- Where appropriate (e.g., in cases involving theft or other criminal activity), inform the police.

Step 3: Risk Assessment

In assessing the risk arising from a data security breach, the relevant stakeholders are required to consider the potential adverse consequences for individuals, i.e., how likely are adverse consequences to materialise and, if so, how serious, or substantial are they likely to be. The information provided at Stage 1 on the Data Security Breach Report Form will assist with this stage.

The Lead Investigator will review the incident report to:

- Assess the risks and consequences of the breach:
 - Risks for individuals:
 - What are the potential adverse consequences for individuals?
 - How serious or substantial are these consequences?
 - How likely are they to happen?
 - Risks for the Parish Council:
 - Strategic & Operational
 - Compliance/Legal
 - Financial
 - Reputational Continuity of Service Levels
- Consider what type of data is involved, how sensitive is it? Were there any protections such as encryption? What has happened to the data? If data has been stolen it could be used for purposes which are harmful to the individuals to whom the data relate; if it has been damaged this poses a different type and level of risk.
- Consider how many individuals' personal data are affected by the breach. It is not necessarily the case that the bigger risks will accrue from the loss of large amounts of data but is certainly an important determining factor in the overall risk assessment.
- Consider the individuals whose data has been breached.
- Consider what harm can come to the affected individuals. Are there risks of physical safety or reputation, of financial loss or a combination?
- Consider if there are wider consequences to consider such as a loss of public confidence in a service the Parish Council provides.
- Determine, where appropriate, what further remedial action should be taken on the basis of the incident report to mitigate the impact of the breach and prevent repetition.

The Lead Investigator will prepare an **incident report** setting out (where applicable):

- A summary of the security breach.
- The people involved in the security breach.
- Details of the information, IT systems, equipment or devices involved in the security breach and any information lost or compromised as a result of the incident.
- How the breach occurred.
- Actions taken to resolve the breach.
- Impact of the security breach.
- Unrealised, potential consequences of the security breach.
- Possible courses of action to prevent a repetition of the security breach.
- Side effects, if any, of those courses of action; and
- Recommendations for future actions and improvements in data protection as relevant to the incident.

This report will be presented to the full Parish Council.

Step 4: Notification

On the basis of the evaluation of risks and consequences, the Lead Investigator will determine whether it is necessary to notify the breach to others outside Killamarsh Parish Council. For example:

- the Police
- individuals (data subjects) affected by the breach.
- the Information Commissioner's Office
- the press/media
- the Parish Councils insurers
- bank or credit card companies
- external legal advisers

As well as deciding **who** to notify, the Lead Investigator must consider:

- **What** is the message that needs to be put across?

In each case, the notification should include as a minimum:

- a description of how and when the breach occurred.
- what data was involved; and
- what action has been taken to respond to the risks posed by the breach.

When notifying individuals, the Lead Investigator should give specific and clear advice on what steps they can take to protect themselves, what the Parish Council is willing to do to assist them and should provide details of how they can contact the Parish Council for further information.

- **How to communicate the message?**

What is the most appropriate method of notification (e.g., are there large numbers of people involved? Does the breach involve sensitive data? Is it necessary to write to each individual affected? Is it necessary to seek legal advice on the wording of the communication?).

- **Why are we notifying?**

Notification should have a clear purpose, e.g., to enable individuals who may have been affected to take steps to protect themselves (e.g., by cancelling a credit card or changing a password), to allow regulatory bodies to perform their functions, provide advice and deal with complaints, etc.

Guidance is available on the ICO website under Data Protection principle 7 Data Security.

Step 5: Evaluation and Response

Subsequent to a data security breach, the Lead Investigator with any relevant stakeholders in the Parish Council will conduct a review to ensure that the steps taken during the incident were appropriate and to identify areas that may need to be improved.

The Lead Investigator will send a copy of all data security breach reports to the full Parish

Council. Considerations are: -

- What action needs to be taken to reduce the risk of future breaches and minimise their impact?
- Whether policies procedures or reporting lines need to be improved to increase the effectiveness of the response to the breach?
- If there are any weak points in security controls that need to be strengthened?
- If staff and users of services are aware of their responsibilities for information security and adequately trained?
- If additional investment is required to reduce exposure and if so, what are the resource implications?

The Policy

Killamarsh Parish Council provides grit bins for self-help by members of the public. The purpose of this policy is to provide criteria against which applications for the placement of grit bins can be assessed.

What is Grit?

Grit is another name for ‘rock salt’ and it helps keep roads and pavements safe by preventing them becoming icy; it works by lowering the temperature at which water freezes. It relies on pedestrian movement on pavements or the action of vehicle tyres to spread it over the road, but it can get too cold for the salt to work. Below -5 degrees centigrade the effectiveness of grit is reduced and pavements/roads may still freeze. Rain or snow can wash the grit away leaving the area prone to re-icing, so gritting ideally needs to take place after rain but before the water freezes.

Spreading the Grit

Safety is the most important factor: Only spread the grit when there are no vehicles or pedestrians about; Wear bright clothing to ensure that you can be seen easily; Don’t assume that the road or footway is safe just because you have spread the grit; Look after the environment – use the minimum grit necessary. A shovel full of grit will be sufficient for 20-30sq.m. For maximum effect the grit should be spread in tyre tracks or on the main foot way used.

Grit Bin Provision

Killamarsh Parish Council will consider provision of a new grit bin when a number of criteria are met. Key factors that are considered include:

- Highway gradient
- Highway safety
- Number of residents to benefit
- Distance to next grit bin
- Other factors, e.g., vulnerable residents; known water problems; junction problems

1. Grit bins shall only be considered where at least one of the criteria in List A and all the criteria in List B are met:

List A (application must meet 1 or more of these criteria)

- ✓ The gradient is greater than 1 in 10.
- ✓ A junction with a known history of accidents.
- ✓ Acceptable number of vulnerable residents.

List B (application must meet all criteria)

- ✓ Not on a Derbyshire County Council primary gritting route.

- ✓ Must be for use on the public highway (road and/or footpath).
- ✓ The location shall not obstruct the passage of pedestrians: a minimum of 1.5m clearance on the footway is required.
- ✓ The location shall not obstruct sight lines.
- ✓ The location is not, normally, within 200m of another grit bin location.
- ✓ The location is within the boundary of the public highway.

2. Where grit bins will not be provided

Killamarsh Parish Council will not provide grit bins in private areas or car parks or any other public or private property; such as schools, parks, hospitals, sheltered accommodation, or similar.

3. Location of grit bins

Grit bins will only be located where they can be easily accessed. Grit bins will be left in situ throughout the year. The location of grit bins will be recorded and made available on the Killamarsh Parish Council website.

4. Filling of grit bins

Grit bins shall be replenished at the start of each winter period and once more during the winter period if required, and on ad-hoc occasions at residents' request if resources permit.

5. Use of grit

The grit in the bin is purely for use on the public highway and footpaths. If the grit is used on private land, consideration will be given to removal of the bin.

6. Application for a new grit bin

This must be in writing or by email to the Parish Office. Applications will be considered at the next available meeting of the Environment & Climate Change Committee, who will then make a recommendation to Full Council, the outcome of which will be recorded in the minutes of the meeting.
